Bidders are hereby informed that plans and specifications for the above-mentioned contract are modified, corrected, and/or supplemented as follows, and that Addendum No. 15 becomes a part of the Contract Documents and consists of the following announcements.

ANNOUNCEMENTS (THESE ITEMS NOT TO BECOME PART OF THE CONTRACT DOCUMENTS AND ARE FOR INFORMATION ONLY)

The results of the remaining Sub Bids are provided in Attachment A.

The following restrictions shall apply:

1. Resilient Flooring: Capital Carpet and Flooring Specialists Inc.- bid may not be used by GVW, CJM Services, Nauset Construction, Nelco Worldwide, or Larieka Construction.

Per the MA Chapter 149, Section 44F:

(4)(a)(1) If no sub-bid is filed for a sub-trade designated in the general bid form or if the only sub-bids which are filed are restricted to the use of one or more general bidders, the awarding authority may state, in an addendum issued with the list of sub-bidders required by subsection (3), that the general bidder shall include in the cost of his own work an amount to cover all the work required for any such sub-trade. The general contractor shall cause the work covered by such sub-trade to be done by a qualified and responsible sub-contractor, subject to the written approval of the awarding authority.

As per addendum 14, the General Contractor shall include within the cost of its own work an amount to cover all the work required for the sub-trades of Elevators and Miscellaneous and Ornamental Iron.
