

Question 1) Temporary Traffic Control Plans

The TTCPs include pay items noted as "Major Items", which do not include item 851.1. However, Item 851.1 is in fact included in the bid proposal pay items. Will MassDOT allow the contractor to use item 851.1 for temporary traffic management?

Response 1) Yes, Item 851.1 is only intended to be used for short term setups necessary to establish the work zones shown in the plan set.

The use of less than 50 cones in a string shall be incidental to the work with no additional compensation, according to Subsection 850.80 of the Standards Specifications.

Question 2) Park Avenue over RT 2

The Park Avenue Bridge is the only structure which requires a Long Term Setup. This setup occurs at the Median Pier. Is this pier location where Jacking and Shoring (8 Each) is required? Will MassDOT further explain which beams must be supported?

Response 2) Both Park Avenue & ST 60 Pleasant Street require Long Term Setups as shown in the TTCP.

Shoring locations may not be limited to these two bridges.

Refer to Item 106.88 in the Special Provisions. The locations will be determined by the Engineer.

Plans will be on display and information will be available at the MassDOT Boston Office and at the District Office in ARLINGTON.

PRICE ADJUSTMENTS

This Contract contains price adjustments for hot mix asphalt and Portland cement mixtures, diesel fuel, and gasoline. For reference the base prices are as follows: liquid asphalt \$575.00 per ton, Portland cement \$425.53 per ton, diesel fuel \$2.559 per gallon, and gasoline \$2.385 per gallon, and Steel Base Price Index 409.2.
